- The nominations and the inclusions are judged solely by visuals submitted by email to artist@mastersoftoday.com. The selection process is free of charges and makes no claim to a deal or to a Publishing Agreement.
- The advertising value in MOT books is US\$ 2,259 per one page but MOT also may offer advertising fees in the form of special offers as the artists-discounted fee or double-discounted advertising rate matching your advertisement cost.
- The advertising fee should be provided after notification of acceptance and after receiving a layout alternative in the book.
- Visual artists' advertisements in MOT Collective Art Book Series are Tax Deductible. The Internal Revenue Service allows professional artists and art galleries to deduct the costs of promoting work, including print advertisements in art books and catalogs, as business-related expenses.
- Each included artist in MOT Collective Art Book Series have right to three copies of the book at the shipping and handling charges based on the delivery option chosen by the artist. The shipping postage cost is not included.
- MOT distribution is through large book wholesalers and ecommerce.
